CITY ORDINANCE NO. CO 44-2017
Series of 2017

AN ORDINANCE APPROVING THE SUPPLEMENTAL BARANGAY BUDGET OF VARIOUS BARANGAYS OF THE CITY OF BACOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Appropriations of various barangays to wit:

1. Mabolo III – Two Hundred Fifty Eight Thousand One Hundred Forty Two Pesos and 66/100 (Php 258,143.66) (Please see attached Barangay Resolution No. 02-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated August 16, 2017), and
2. Zapote IV – Six Hundred Ten Thousand Fifty Six Pesos and 87/100 (Php 610,056.87) (Please see attached Barangay Resolution No. 01-2017 Series of 2017 and Appropriation Ordinance No. 02-2017 Series of 2017 dated September 4, 2017)

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangays Mabolo III and Zapote IV, provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive and others concerned for their information and guidance.






