





CITY ORDINANCE NO. CO 48-2017

AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MAMBOG I AMOUNTING TO TWO MILLION EIGHT HUNDRED THIRTY THOUSAND PESOS (PHP 2,830,000.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Mambog I in the amount of **Two Million Eight Hundred Thirty Thousand Pesos (Php 2,830,000.00)**. Attached is the Barangay Resolution No. 2017-015 and Appropriation Ordinance No. 02-2017 dated August 22, 2017.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Appropriation of Barangay Mambog I provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
