AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Annual General Fund Budget of various Barangays to wit:

1. Molino III – Thirty Four Million Two Hundred Six Thousand Forty Two Pesos (Php 34,206,042.00) (Please see attached Barangay Resolution No. 079-16 and Barangay General Appropriation Ordinance No. 03-2016 dated October 15, 2016);
2. Habay I – Eleven Million Five Hundred Forty Five Thousand Two Hundred Forty Four Pesos (Php 11,545,244.00) (Please see attached Barangay Resolution No. 04 s.2016 and Barangay General Appropriation Ordinance No. 04-2016 dated October 29, 2016);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Annual General Fund Budget of Barangays Molino III and Habay I, provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Molino III and Habay I, and Aniban I, and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
