**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY HABAY I AMOUNTING TO NINE HUNDRED FIFTY THOUSAND PESOS (PHP 950,000.00 ) OF THE CITY OF BACOR, PROVINCE OF CAVITE.**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Habay I in the amount of Nine Hundred Fifty Thousand Pesos (Php 950,000.00 ).
