CITY ORDINANCE NO. CO 59-2017

Series of 2017

AN ORDINANCE IMPOSING A TWO-PESO (P 2.00) SURCHARGE FOR EVERY TICKET SOLD IN ALL MOVIE THEATERS IN THE CITY OF BACOR, COVERING THE PERIOD BETWEEN JANUARY 01 TO JANUARY 30, 2018, THE PROCEEDS OF WHICH SHALL BE USED TO FINANCE THE HUMANITARIAN ACTIVITIES OF THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY IN THE BACOR CITY JAIL AND THE MAINTENANCE COST OF THE GIRLS' HOME AND SHELTER FOR BOYS.

WHEREAS, the BJMP-Bacoor City Jail is a detention facility for people in conflict with the law which needs support for the welfare of its detainees.

WHEREAS, the Girls' Home and Shelter for Boys is a temporary haven for orphans, street-children some of them victims of parental neglect or are physically and emotionally abused.

WHEREAS, the inmates at the BJMP-Bacoor City Jail and the residents of the Girls' Home and Shelter for Boys represents the less-fortunate and marginalized in society.

WHEREAS, a community approach is essential in the process of inmate rehabilitation and care for neglected and orphaned children.

WHEREAS, the celebration of the Christmas and New Year are traditionally a season for gift-giving and are appropriate times to extend help to the less-fortunate and marginalized in society.

WHEREAS, it is necessary for the less-fortunate and marginalized in society to feel the care and support of the community particularly during the celebration of Christmas and the welcoming of the New Year.

WHEREAS, by imposing a two-peso (P 2.00) surcharge for every ticket sold in all movie theatres within the City of Bacoor from January 1-30, 2018, there shall be a fund source to financ the humanitarian activities of the BJMP-Bacoor City Jail and the Girls' Home and Shelter for Boys.

BE IT ORDAINED by the Sangguniang Panlungsod in regular session duly assembled THAT:

Section 1. TWO-PESO SURCHARGE. – A two-peso (P 2.00) surcharge for each ticket sold in all theatres/cinemas within the City of Bacoor is hereby imposed but only from January 01 to 30, 2018;

Section 2. PROCEEDS. – The proceeds of which imposition shall be defrayed to the BJMP-Bacoor City Jail and Girls' Home and Shelter for Boys in support of the rehabilitation and welfare of its respective residents.

Section 3. AMOUNT OF COLLECTION. – The total amount generated from this ordinance shall be equally divided in favor of the BJMP-Bacoor City Jail and the Girls' Home and Shelter for Boys subject to prevailing government auditing regulations.

Section 4. NOTICE. – A printed notice (e.g. Ads standee, tarpaulin, banner or billboard) shall be placed besides or in close proximity to the ticket booth of each theatre/cinema citing the purpose of the surcharge as a fundraising for the specified beneficiaries.

Section 5. EXEMPTION. – Senior Citizens availing of their free movie benefit pass are exempted from the collection of the surcharge. Only regular patrons are covered by this ordinance.

Section 6. EFFECTIVITY. This ordinance shall take effect upon its approval.
