**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET
OF VARIOUS BARANGAYS IN THE CITY OF BACOR.**

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

1. Mambog IV – Four Hundred Two Thousand Nine Hundred Twenty Nine Pesos and 91/100 (Php 402,929.91) (Please see attached Sangguniang Barangay Resolution No. 01-2018 and Appropriation Ordinance No. 01-2018 dated July 02, 2018);
2. Talaba VII – One Hundred Thirty Six Thousand Pesos (Php 136,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated July 07, 2018);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of the following Barangays Mambog IV and Talaba VII provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
