**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF  
VARIOUS BARANGAYS IN THE CITY OF BACOR.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

1. Bayanan – One Million Pesos (Php 1,000,000.00) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated August 13, 2018); and
2. Sineguleasan – Three Hundred Twenty Two Thousand One Hundred Ninety Pesos and 28/100 (Php 322,190.28) (Please see attached Sangguniang Barangay Resolution No. 01-2018 Series of 2018 and Appropriation Ordinance No. 01-2018 Series of 2018 dated July 28, 2018).

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of the following Barangays Bayanan and Sineguleasan provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

**ORDAINED FURTHER**, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Bayanan and Sineguleasan and others concerned for their information and guidance.

**ORDAINED LASTLY**, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.






