Rowena Bautista-Mendiola unanimously seconded by the members present in regular session duly assembled **BE IT RESOLVED, AS IT IS HEREBY ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor to approve the reversion/reprogramming of funds under the budget of the City Environment and Natural Resources Office "Maintenance and Other Operating Expenses" to pay for the cost of hauling of garbage expenses as indicated above covered by Annual General Fund for CY 2018 to wit;

**Section 1.** The purpose of this ordinance is to appropriate the amount of Sixteen Million Three Hundred Fifty Thousand (PhP 16,350,000.00) for the garbage hauling expenses under the City Environment and Natural Resources Office for Calendar Year 2018;

**Section 2.** The above-mentioned amount of Sixteen Million Three Hundred Fifty Thousand (PhP 16,350,000.00) shall be reverted/reprogrammed from the "Maintenance and Other Operating Expenses" to the "Environmental Sanitary Services" (Contract on Garbage Hauling) under the City Environment and Natural Resources Office (CENRO) budget covered under the annual General Fund for Calendar Year 2018;

**Section 3.** The City Treasurer is hereby authorized to disburse the afore-mentioned amount for the purpose herein stated;

**Section 4.** This Appropriation Ordinance shall take effect upon its approval.
