AN ORDINANCE RENAMING, SEPARATING, AND ESTABLISHING VARIOUS PUBLIC SCHOOLS IN THE CITY OF BACOR, CAVITE.

WHEREAS, on 4 July 2019, an endorsement letter was sent by the Office of the City Mayor to the Sangguniang Panlungsod requesting for an ordinance renaming, converting, establishing and separating various public secondary schools in the City of Bacoor, Cavite that aims to better address the educational needs of the students and the faculty by giving each school its autonomy to implement the K-12 program and effectively introduce improvement in their school facilities and programs.

NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola seconded by Councilor Reynaldo D. Palabrica unanimously approved by all the councilors present, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod in regular session assembled that:

Section 1. Separation of high schools from main campus and renaming the said high schools. In order to avoid public confusion, the following schools are hereby separated from their respective "mother schools" and renamed as follows:

Section 2. Establishment of Senior High Schools.

The following new public senior high schools are hereby established:

- City of Bacoor Senior High School-Green Valley;
- City of Bacoor Senior High School-Dulong Bayan;
- City of Bacoor Senior High School - Bayanan
- City of Bacoor Senior High School-Alima;

Section 3. Separability Clause. – If, for any reason or reasons, any part of the provisions of this Ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. Repealing Clause. – All Ordinances, resolutions, Circulars, Memorandums or Rules and regulations inconsistent with the provision of this Ordinance are hereby repealed and modified accordingly.


Section 5. Effectivity Clause. – This Ordinance shall take effect immediately upon its posting in at least three (3) conspicuous places within the City of Bacoor after it has





