**NOW THEREFORE**, upon unanimous motion of all the councilors present in regular session assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds under the budget of the Office of the Sangguniang Panlungsod from the "Other Maintenance & Operating Expenses" to the payment of expenses to be incurred for "Training Expenses; Fuel, Oil and Lubricant Expenses; and Office Supplies Expenses".

Be it enacted by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled that:

**Section 1.** The purpose of this Ordinance is to appropriate the amount of Three Million Six Hundred Fifty Thousand Pesos (PhP3,650,000.00) for the payment of expenses to be incurred for Training Expenses; Fuel, Oil and Lubricant Expenses; and Office Supplies Expenses.

**Section 2.** The above-mentioned amount of Three Million Six Hundred Fifty Thousand Pesos (PhP3,650,000.00) shall be realigned from the "Other Maintenance & Operating Expenses" under the budget of the Office of the Sangguniang Panlungsod for Calendar Year 2019;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** —This Appropriation Ordinance shall take effect upon its approval.
