AN ORDINANCE APPROVING THE ANNUAL BUDGET OF

2. Queen's Row West – One Million One Hundred Thousand Two Hundred Eight Pesos and 70/100 (Php1,100,208.70) (Please see attached Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 16, 2019);
3. Talaba IV – Three Hundred Fifty Four Thousand Seven Hundred Thirty Seven Pesos and 40/100 (Php354,737.40) (Please see attached Sangguniang Kabataan Resolution No. 003 Series of 2019 dated March 25, 2019); and
4. Mambog II – Five Hundred Thirty Six Thousand Two Hundred Seventy Seven Pesos and 60/100 (Php536,277.60) (Please see attached Sangguniang Kabataan Resolution No. 001 Series of 2019 dated March 20, 2019);
