**AN ORDINANCE INSTITUTIONALIZING THE "ALAGANG ATE LANI PROGRAM", IDENTIFYING ITS OBJECTIVES, AND MAKING THE SAID PROGRAM AS THE FLAGSHIP PROGRAM OF THE OFFICE OF THE MAYOR OF THE CITY OF BACOR, CAVITE.**

**BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite THAT:

**Section 1. Short Title.** This Ordinance shall be known as the "**ALAGANG ATE LANI PROGRAM ORDINANCE OF THE CITY OF BACOR**".

**Section 2. Purposes.** This Ordinance is intended to achieve the following:

2.1. Institutionalize the "ALAGANG ATE LANI PROGRAM";

2.2. Effectively implement the various programs of the city government under the administration of the Local Chief Executive, Hon. Lani Mercado-Revilla; and


2.3. Increase community involvement and awareness in the implementation of the various programs under the ALAGANG ATE LANI PROGRAM.

**Section 3. Institutionalization.** The ALAGANG ATE LANI PROGRAM is hereby institutionalized and created for it to serve as the flagship program of the city government under





**Section 4. Program Objectives.** The ALAGANG ATE LANI PROGRAM (the "Program") shall have the following objectives:

4.1. Increase community involvement and awareness in the implementation of the various projects under the Program;

4.2. Create a means of measuring the effectiveness of the various projects under the Program; and

4.3. Ensure that all projects under the Program are effectively implemented in compliance with law.

**Section 5. Program Components.** The Program shall be comprised of the following:


- Alagang ATE LANI Caravan;
- Free Medical and Dental Mission (CHO);
- Libreng Gupit, Libreng Masahe (Livelihood);
- Late Birth Registration (LCR);
- PWD and Senior Citizen Registration (OSCA and PWD)
- Job's Fair (PESO);
- Feeding Program (CSWD);
- Trainings of Rescue and Response among Constituents (BDRRMO);
- Libreng Salamin;
- Libreng Pustiso;
- Free Eye Cataract Operation;
- Alagang ATE LANI (Information Drive);
- Information and Education Campaign (IEC) on Garbage Segregation (CENRO);
- Anti-Drug Information Seminar (PNP; 45 days LMR Volunteers; PDEA); and
- Other projects that were fully funded in the Annual Budget of the City of Bacoor.

**Section 6. Separability Clause.** In case any provision of this Ordinance is found void by a court of law, the other provisions hereof not affected by such declaration shall remain valid.









Effectivity Clause.** This Ordinance shall become effective fifteen (15) days after it has been published at least twice in a newspaper of general circulation, posted on at least three (3) conspicuous places within the City of Bacoor, and after the Sangguniang Panlalawigan has approved it.
