**CITY ORDINANCE NO. CO 35-2019**

**AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MABOLO II, CITY OF BACOR, CAVITE AMOUNTING TO EIGHTY THOUSAND PESOS (PHP 80,000.00).**

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Mabolo II in the amount of **Eighty Thousand Pesos (Php 80,000.00)**. **WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Alde Joselito F. Pagulayan duly seconded by Hon. Victoria L.
