**AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY HABAY I IN THE CITY OF BACOR, PROVINCE OF CAVITE.**

**WHEREAS**, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Sangguniang Kabataan Budget of Barangay Habay I in the amount of One Million Four Hundred Forty Thousand Eight Hundred Twenty Eight Pesos and 60/100 (Php 1,440,828.60).

**WHEREFORE**, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Mac Raven Espiritu duly seconded by Hon. Michael E.
