**SERIES OF 2019**

**AN ORDINANCE REALIGNING THE AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP 2,500,000.00) FROM "MAINTENANCE AND OTHER OPERATING EXPENSES (TELEPHONE EXPENSES, REPAIRS AND MAINTENANCE-MACHINERY AND EQUIPMENT AND INSURANCE EXPENSES- CITY BUILDINGS)" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "MAINTENANCE AND OTHER OPERATING EXPENSES (WATER EXPENSES)" IN THE GENERAL SERVICES OFFICE (GSO), CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2019.**

**NOW THEREFORE**, upon motion of Hon. Alde Joselito F. Pagulayan seconded by Hon. Roberto R. Javier and Hon. Roberto L. Advincula in regular session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Two Million Five Hundred Thousand Pesos (Php 2,500,000.00)** from "Maintenance & Other Operating Expenses (Telephone, Repairs and Maintenance-Machinery and Equipment, and Insurance Expense-City Buildings)" to the payment of expenses to be incurred under the "Maintenance and Other Operating Expenses (Water Expenses)" in the General Services Office (GSO), City Government of Bacoor, Cavite for Calendar Year 2019.

**BE IT ENACTED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Session assembled THAT :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of **Two Million Five Hundred Thousand Pesos (Php2,500,000.00)** for the "Maintenance and Other Operating Expenses (Water Expenses)" under the budget of the General Services Office (GSO) for Calendar Year 2019;

**Section 2.** The above-mentioned amount of **Two Million Five Hundred Thousand Pesos (Php2,500,000.00)** shall be realigned from the "Maintenance & Other Operating Expenses (Telephone, Repairs and Maintenance-Machinery and Equipment, and Insurance Expense-City Buildings)" under the budget of the General Services Office (GSO) for Calendar Year 2019;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** This Appropriation Ordinance shall take effect upon its approval.
