AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY MABOLO I IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Mabolo I in the amount of Two Hundred Twenty Four Thousand Seven Hundred Ninety Four Pesos and 40/100 (Php 224,794.40).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Adrielito G. Gawaran and Hon. Alde Joselito F. Pagulayan in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangay Mabolo I provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Sangguniang Kabataan Chairman of Barangay Mabolo I and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
