



Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriations of Barangay Panapaan IV in the amount of **Four Hundred Eighty Thousand Pesos (Php 480,000.00)**. 
