AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF VARIOUS BARANGAYS IN THE CITY OF BACOOR.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite are the Supplemental Budget of various Barangays to wit:

1. Aniban IV – Ninety Nine Thousand Eight Hundred Pesos (Php 99,800.00) (Please see attached Sangguniang Barangay Appropriation Ordinance No. 2019-001 dated September 11, 2019);
2. Habay I – Seven Hundred Ninety Five Thousand Pesos (Php 795,000.00) (Please see attached Sangguniang Barangay Appropriation Ordinance No. 2019-001 dated September 27, 2019);

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena Bautista-Mendiola duly seconded by Hon. Michael E. Solis, in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of Barangays Aniban IV and Habay I provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Punong Barangay of Barangays Aniban IV and Habay I and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangays mentioned above and on two (2) other conspicuous places within the City of Bacoor.
