AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO VI AMOUNTING TO SEVEN HUNDRED EIGHTY THOUSAND PESOS (PHP 780,000.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of Barangay Molino VI in the amount of **Seven Hundred Eighty Thousand Pesos (Php 780,000.00)**. Please see attached is the Barangay Appropriation Ordinance No. 2019-001 dated September 2, 2019.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena B. Mendiola duly seconded by Hon. Hernando C.
