AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY MOLINO II AMOUNTING TO ONE MILLION NINE HUNDRED THOUSAND PESOS (PHP 1,900,000.00) OF THE CITY OF BACOR, PROVINCE OF CAVITE.

Submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Supplemental Appropriation of Barangay Molino II in the amount of **One Million Nine Hundred Thousand Pesos (Php 1,900,000.00)**. Please see attached is the Barangay Appropriation Ordinance No.1 Series of 2019 dated September 2, 2019.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena B. Mendiola duly seconded by Hon. Leandro A. De Leon in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, to approve the Supplemental Budget of Barangay Molino II provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.
