AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY NIOG II IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Niog II in the amount of Six Hundred Twenty Eight Thousand Eight Hundred Seventy Three Pesos and 60/100 (Php 628,873.60). Please see attached is the Sangguniang Kabataan Resolution No.003 Series of 2019 dated May 5, 2019.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena Bautista-Mendiola duly seconded by Hon. Mac Raven Espiritu in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangay Niog II provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED FURTHER, to furnish copies of this ordinance to the Office of the Local Chief Executive, the Sangguniang Kabataan Chairman of Barangay Niog II and others concerned for their information and guidance.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
