AN ORDINANCE APPROVING THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY KAINGEN IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual Budget of Sangguniang Kabataan of Barangay Kaingen in the amount of Four Hundred Thousand One Hundred Fifty Five Pesos (Php 400,155.00). Please see attached is the Sangguniang Kabataan Resolution No.001 Series of 2019 dated February 25, 2019.

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, on motion of Hon. Rowena Bautista-Mendiola duly seconded by Hon. Alejandro F. Gutierrez in its regular session assembled, **HEREBY ORDAINED AS IT IS HEREBY ORDAINED**, by the Sangguniang Panlungsod to approve the Annual Budget of Sangguniang Kabataan of Barangay Kaingen provided that the above-mentioned budget complies with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.

ORDAINED LASTLY, that this Ordinance shall take effect immediately after its posting on the bulletin board of the barangay mentioned above and on two (2) other conspicuous places within the City of Bacoor.
