APPROPRIATION ORDINANCE NO. CO 57-2019
Series of 2019

AN ORDINANCE AUTHORIZING THE GRANT OF SERVICE RECOGNITION INCENTIVE AMOUNTING TO TEN THOUSAND PESOS (PHP10,000.00) TO ALL ELECTED AND APPOINTED PERMANENT, CASUAL, AND CO-TERMINOUS OFFICIALS AND EMPLOYEES OF THE CITY GOVERNMENT OF BACOR AS A REWARD TO RECOGNIZE AND ENCOURAGE THE UNWAVERING COMMITMENT AND DEDICATION OF GOVERNMENT EMPLOYEES IN PERFORMING THEIR WORK, THEIR CONTINUED SUPPORT AND COLLABORATIVE EFFORTS IN THE DELIVERY OF SERVICES TO THE PUBLIC AND APPROPRIATING THE AMOUNT OF NINE MILLION SEVEN HUNDRED TEN THOUSAND PESOS (PHP9,710,000.00) FROM ANY AVAILABLE SAVINGS FOR PERSONAL SERVICES UNDER THE 2019 ANNUAL BUDGET OF THE CITY GOVERNMENT PURSUANT TO THE ADMINISTRATIVE ORDER NO. 19 DATED DECEMBER 2, 2019 ISSUED BY THE OFFICE OF THE PRESIDENT.

WHEREAS, under Section (17) (iv) of Congress Joint Resolution (JR) No. 4 dated 17 June 2009, the President upon the recommendation of the Department of Budget and Management (DBM), is authorized to update the Compensation and Position Classification System (CPCS) for civilian personnel and Base Pay Schedule for military and uniformed personnel as well as the policies on and levels of allowances, benefits and incentives applicable to all government personnel;

WHEREAS, on 2 December 2019, the Office of the President issued Administrative Order No. 19 authorizing the grant of Service Recognition Incentive to government employees for Fiscal Year (FY) 2019 as a reward to recognize and encourage the unwavering commitment and dedication of government employees in performing their work, their continued support and collaborative efforts in the delivery of services to the public.

WHEREAS, on 5 December 2019, the Office of the City Mayor sent a letter to the Sangguniang Panlungsod requesting to pass an Ordinance authorizing the grant of Service Recognition Incentive (SRI) in the amount of **Ten Thousand Pesos (PhP10,000.00)** to all qualified employees (Permanent, Co-Terminous, and Casual) of the City Government of Bacoor or a total amount of **Nine Million Seven**





Hundred Ten Thousand Pesos (Php9,710,000.00) to be taken from Personal Services Savings for Fiscal Year 2019 pursuant to Administrative Order No. 19. Attached as **Annex "A"** is a copy of the computation of Personal Services Savings for the grant of Service Recognition Incentive (SRI).

WHEREAS, in the afternoon of 6 December 2019, the Sangguniang Panlungsod deliberated on the abovementioned matter and unanimously decided to pass the instant Ordinance.

NOW THEREFORE, BE IT ORDAINED by the 4th Sangguniang Panlungsod of the City of Bacoor, Cavite in special session duly assembled THAT:

Section 1. Title. This Ordinance shall be known and referred to as the **"2019 Service Recognition Incentive Ordinance of the City of Bacoor"**.

Section 2. Effectivity. The provisions of this Ordinance shall take effect upon its approval.

Section 3. Coverage. This Ordinance shall apply in favor of all permanent, casual, and co-terminous officials and employees of the local government of the City of Bacoor.


Section 4. Service Recognition Incentive (SRI). The grant of service recognition incentives amounting to **Ten Thousand Pesos (Php10,000.00)** each is hereby authorized in favor of all permanent, casual, and co-terminous officials and employees of the city government who are covered by this Ordinance.

Section 5. Appropriation. The amount of **Nine Million Seven Hundred Ten Thousand Pesos (Php9,710,000.00)** is hereby appropriated from any available savings for Personal Services under the 2019 Annual Budget pursuant to the Administrative Order No. 19 dated December 2, 2019 issued by the Office of the President.

ENACTED by the Sangguniang Panlungsod of Bacoor in its Special Session this 6th day of December 2019.
