**CITY ORDINANCE NO. CO 134-2020**  
**Series of 2020**

**AN ORDINANCE AMENDING SECTION 14 OF CITY ORDINANCE NO. CO 130-2020, SERIES OF 2020, ALSO KNOWN AS "AN ORDINANCE AMENDING VARIOUS SECTIONS OF THE REVISED TRAFFIC CODE OF THE CITY OF BACOR, IMPOSING NEW REGULATIONS ON THE CLAMPING, TOWING AND IMPOUNDING OF ILLEGALLY PARKED MOTOR VEHICLES, CREATING THE BACOR IMPOUNDING AND TOWING UNIT, AND INCREASING THE TOWING AND IMPOUNDING FEES TO BE CHARGED BY THE BACOR TRAFFIC MANAGEMENT DEPARTMENT AGAINST THE OWNERS OF THE SAID VEHICLES".**

**WHEREAS**, on 19 October 2020, the Sangguniang Panlungsod passed City Ordinance No. CO 130-2020 (also known as "**An Ordinance Amending Various Sections Of The Revised Traffic Code Of The City Of Bacoor, Imposing New Regulations On The Clamping, Towing And Impounding Of Illegally Parked Motor Vehicles, Creating The Bacoor Impounding And Towing Unit, And Increasing The Towing And Impounding Fees To Be Charged By The Bacoor Traffic Management Department Against The Owners Of The Said Vehicles**");

**WHEREAS**, Section 14 of the said Ordinance provides that:

**"Section 14. Effectivity.** – This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof." xxx.

**WHEREAS**, on 30 October 2020, the City Mayor, Hon. Lani Mercado-Revilla, formally requested the Sangguniang Panlungsod to pass an ordinance amending Section 14 of City Ordinance No. CO 130-2020.



**Section 1.** Section 14 of City Ordinance No. CO 130-2020 is hereby amended and shall henceforth read as follows:


**“Section 14. Effectivity. - This Ordinance shall take effect fifteen (15) days after its publication once a week for three (3) consecutive weeks in a newspaper of general circulation within the City of Bacoor, Cavite and after its has been posted in three (3) conspicuous places within the City of Bacoor, Cavite”xxx.**


**Section 2.** The Sangguniang Panlungsod of Bacoor shall furnish the Office of the City Mayor, the Bacoor Traffic Management Department (BTMD), the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government offices and agencies concerned with copies of this Ordinance.


**Section 3.** This Ordinance shall take effect fifteen (15) days after its publication once a week for three (3) consecutive weeks in a newspaper of general circulation within the City of Bacoor, Cavite and after its has been posted in three (3) conspicuous places within the City of Bacoor, Cavite.
