CITY ORDINANCE NO. CO 62-2020

AN ORDINANCE APPROVING THE ANNUAL GENERAL FUND BUDGET FOR FISCAL YEAR 2020 OF VARIOUS BARANGAYS IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, submitted for consideration and approval of the Sangguniang Panlungsod of Bacoor, Province of Cavite is the Annual General Fund Budget for Fiscal Year 2020 of various Barangays in the City of Bacoor, Province of Cavite to wit:

1. Talaba IV – Three Million Nine Hundred Forty Seven Thousand Three Hundred Two Pesos (Php 3,947,302.00) (Please see attached Sangguniang Barangay Appropriation Ordinance No. 2020-001 Series of 2020 dated January 31, 2020); and
2. Queens Row West – Twelve Million Two Hundred Forty Eight Thousand Nine Hundred Forty Pesos (Php 12,248,940.00) (Please see attached Sangguniang Barangay Appropriation Ordinance No. 2020-001 Series of 2020 dated January 8, 2020).

WHEREFORE, after thorough deliberation on the aforementioned barangay budget, the Sangguniang Panlungsod on regular session assembled, **HEREBY ORDAINED AS IT IS** **HEREBY ORDAINED**, to approve the Annual General Fund Budget of Barangay Talaba IV and Barangay Queens Row West provided that the above-mentioned budgets comply with the pertinent provisions of RA 7160 and other prevailing laws, circulars and memoranda.


