AN ORDINANCE REALIGNING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) FROM THE "OTHER MAINTENANCE & OPERATING EXPENSES (CHILDREN PROTECTION ACTIVITIES)" AND "OTHER MAINTENANCE & OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "DRUGS AND MEDICINES EXPENSES (FLU VACCINES FOR EMPLOYEES)" IN THE ANNUAL BUDGET OF THE CITY HEALTH OFFICE, CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2020.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Five Hundred Thousand Pesos (Php 500,000.00)** from the "Other Maintenance & Operating Expenses (Children Protection Activities)" and "Other Maintenance & Operating Expenses" to the payment of expenses to be incurred under the "Drugs and Medicines Expenses (Flu Vaccines for Employees)" in the budget of the City Health Office, City Government of Bacoor, Cavite for Calendar Year 2020.

**BE IT ORDAINED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of **Five Hundred Thousand Pesos (PhP500,000.00)** for the "Drugs and Medicines Expenses (Flu Vaccines for Employees)" under the budget of the City Health Office for Calendar Year 2020;

**Section 2.** The above-mentioned amount of **Five Hundred Thousand Pesos (PhP500,000.00)** shall be realigned from the "Other Maintenance & Operating Expenses (Children Protection Activities)" and "Other Maintenance & Operating Expenses" under the budget of the City Health Office for Calendar Year 2020;


**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;
