AN ORDINANCE AUTHORIZING THE DISBURSEMENT OF FUNDS SPECIFIED IN THE APPROVED WORK PROGRAMS FOR THE UTILIZATION OF 15% OF THE TRUST FUND UNDER THE OFFICE OF THE CITY BUILDING OFFICIAL, CITY GOVERNMENT OF BACoor, CAVITE.

WHEREAS, on 23 February 2021, the Office of the City Administrator sent a letter requesting the Sangguniang Panlungsod to enact an appropriation ordinance to disburse the approved work programs for the utilization of 15% of the Trust Fund of the Office of the City Building Official amounting to Five Million One Hundred Thousand Pesos (PhP5,100,000.00).

WHEREAS, a copy of the 2021 Project Procurement Management Plan (PPMP) of the Office of the City Building Official and the Certificate of Availability of Funds signed by the City Accountant, Mr. Jerry Macalatan, were sent to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, the abovementioned matter was referred to the Committee on Finance, Budget and Appropriation as lead Committee as well as to the Committee on Public Works and Highways, and to the Committee on Rules, Privileges, Law and Ordinances for further study and evaluation.

WHEREAS, after conducting a public hearing thereon, the said committees decided to recommend the approval of the disbursement of the approved work program mentioned above amounting to Php5,100,000.00.
