AN ORDINANCE APPROVING THE SUPPLEMENTAL PLANS AND PROGRAMS OF THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE ON THE UTILIZATION OF THE DONATED AMOUNT CREDITED UNDER THE SPECIAL TRUST FUND OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF-TF) OF THE CITY GOVERNMENT OF BACOR, CAVITE.

Section 2. Source of Funds. The source of funds for the disbursement of the above mentioned projects, programs and activities in the amount of **Four Hundred Thirty Four Thousand and Seventy Two Pesos (PhP434,072.00)** is from the donation of a private individual to the City Government of Bacoor under the Special Trust Fund of the Local Disaster Risk Reduction and Management Fund (LDRRMF-TF).

Section 3. Repeal. All ordinances, resolutions, and executive orders inconsistent with this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect ten (10) days from the date a copy hereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) conspicuous places in the City of Bacoor not later than five (5) days after approval thereof.

Section 5. Dissemination. The Sangguniang Panlungsod Secretariat is hereby directed to furnish the Office of the City Budget Officer, the City Accounting Office, the City Treasurer's Office, the BDRRMO, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and all government agencies and offices concerned with copies of this ordinance.
