APPROPRIATION ORDINANCE NO. CO 169-2021

AN ORDINANCE REALIGNING THE AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (PHP 800,000.00) FROM THE "TRAINING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OTHER SUPPLIES AND MATERIALS EXPENSES" IN THE ANNUAL BUDGET OF THE OFFICE OF THE CITY VICE MAYOR AND REALIGNING THE AMOUNT OF ONE MILLION FOUR HUNDRED THOUSAND PESOS (PHP1,400,000.00) FROM THE "OTHER MAINTENANCE AND OPERATING EXPENSES" TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "OFFICE SUPPLIES EXPENSES" AND "ADVERTISING EXPENSES" IN THE ANNUAL BUDGET OF THE OFFICE OF THE SANGGUNIANG PANLUNGSOD, CITY GOVERNMENT OF BACOOR, CAVITE FOR CALENDAR YEAR 2021.

2) the realignment of funds amounting to **One Million Four Hundred Thousand Pesos (PhP1,400,000.00)** from the "Other Maintenance and Operating Expenses" to the payment of expenses to be incurred under the "Office Supplies Expenses" and "Advertising Expenses" in the budget of the Sangguniang Panlungsod, City Government of Bacoor, Cavite for Calendar Year 2021.

**BE IT ORDAINED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

**Section 1.** The purpose of this Ordinance is to appropriate (1) the amount of **Eight Hundred Thousand Pesos (PhP800,000.00)** for the "Other Supplies and Materials Expenses" under the budget of the City Vice Mayor's Office; and (2) the amount of **One Million Four Hundred Thousand Pesos (PhP1,400,000.00)** for the "Office Supplies Expenses" and "Advertising Expenses" under the budget of the Sangguniang Panlungsod Office for Calendar Year 2021;

**Section 2.** The amount of **Eight Hundred Thousand Pesos (PhP800,000.00)** shall be realigned from the "Training Expenses" under the budget of the City Vice Mayor's Office - and the amount of **One Million Four Hundred Thousand Pesos (PhP1,400,000.00)** shall be realigned from the "Other Maintenance and Operating Expenses" under the budget of the Sangguniang Panlungsod for Calendar Year 2021;

**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;

**Section 4.** This Ordinance shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of Bacoor and in at least two (2) other conspicuous places in the City of Bacoor not later than five (5) days after the approval thereof.

**Section 5.** The Sangguniang Panlungsod Secretariat is hereby directed to submit certified true copies of this Ordinance to the University of the Philippines-Office of the National Administrative Register pursuant to Section 3, Book VII of the Administrative Code of 1987 (E.O. 292).
