AN ORDINANCE REALIGNING THE AMOUNT OF THREE MILLION PESOS (PHP 3,000,000.00) FROM THE "INSURANCE EXPENSES (GOVERNMENT BUILDINGS)", TO THE PAYMENT OF EXPENSES TO BE INCURRED UNDER THE "FUEL, OIL AND LUBRICANTS EXPENSES" IN THE ANNUAL BUDGET OF THE GENERAL SERVICES OFFICE (GSO), CITY GOVERNMENT OF BACOR, CAVITE FOR CALENDAR YEAR 2021.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola duly seconded by Hons. Miguel N. Bautista, Leandro A. De Leon, Alejandro F. Gutierrez, Hernando C. Gutierrez, and Alde Joselito F. Pagulayan in regular online session duly assembled, **BE IT ORDAINED AS IT IS HEREBY ORDAINED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to approve the realignment of funds amounting to **Three Million Pesos (PhP3,000,000.00)** from the "Insurance Expenses (Government Buildings)" to the payment of expenses to be incurred under the "Fuel, Oil and Lubricants Expenses" in the budget of the General Services Office, City Government of Bacoor, Cavite for Calendar Year 2021.

**BE IT ORDAINED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite in Regular Online Session assembled THAT :

**Section 1.** The purpose of this Ordinance is to appropriate the amount of **Three Million Pesos (PhP3,000,000.00)** for the "Fuel, Oil and Lubricants Expenses" under the budget of the General Services Office for Calendar Year 2021;


**Section 2.** The above-mentioned amount of **Three Million Pesos (PhP3,000,000.00)** shall be realigned from the "Insurance Expenses (Government Buildings)" under the budget of the General Services Office for Calendar Year 2021;


**Section 3.** The City Treasurer is hereby authorized to disburse the aforesaid amount for the purpose herein above-stated;


