WHEREAS, an alleged robbery extortion took place on 5 July 2022 at around 9:00 p.m. in front of SM City-Bacoor, along Aguinaldo Highway, Barangay Panapaan 5, Bacoor City, Cavite.

WHEREAS, the victim was a Dutch national named Marek A. Moens, 28 years old and a resident of Den Helder, Netherlands who reported that two traffic enforcers allegedly mulcted Php 4,000.00 from him for a traffic violation that he did not commit.

WHEREAS, the officers of the Bacoor City Police PSSg Arnold D. Mendoza and Pat Kempee S. Lopez, headed by Bacoor City Chief of Police P/Col. Gilbert C. Cruz arrested Traffic Law Enforcers, Albert G. Velasquez and Carl Xavier A. Galang who allegedly committed the said crime.

WHEREAS, the victim sought help from the Cavite Mobile Patrol Unit which resulted to the arrest and recovery of the money mentioned above.

WHEREAS, the Sangguniang Panlungsod believes that the Bacoor City Police is worthy of commendation because of the expeditious and decisive action of the above-mentioned officers on the complaint of Mr. Moens.
