A RESOLUTION REQUESTING THE CITY MAYOR TO DIRECT THE CITY TREASURER AND THE PUBLIC INFORMATION OFFICE OF THE CITY OF BACOR TO INFORM THE PUBLIC THAT THE DEADLINE FOR PAYMENT OF REAL PROPERTY TAXES SHALL BE ON DECEMBER 31, 2022 AND THAT NO EXTENSION OF THE SAID DEADLINE SHALL BE GRANTED BY THE CITY GOVERNMENT.

WHEREAS, the Commission on Audit advised the City Government to discontinue the said practice as it apparently has no legal basis.

WHEREAS, the City Government has no choice but to heed the advice of the Commission on Audit on the said matter.
