A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) ON BEHALF OF THE CITY GOVERNMENT OF BACORR RELATIVE TO THE IMPLEMENTATION OF THE NATIONAL CULTURAL HERITAGE ACT OF 2009.

WHEREAS, on July 19, 2022, the Office of the City Mayor requested the Sangguniang Panlungsod to pass a resolution authorizing Hon. Strike B. Revilla to sign and enter into a Memorandum of Understanding with the National Commission for Culture and the Arts (NCCA) relative to Republic Act No. 10066 otherwise known as the "National Cultural Heritage Act of 2009" which mandates the NCCA to protect and conserve the country's national cultural heritage;

WHEREAS, Section 16 of Republic Act No. 7160 (Local Government Code of 1991), encourages every local government unit to ensure and support the preservation and enrichment of culture.

WHEREAS, the NCCA has prioritized the conduct of "Local Cultural Mapping" pursuing research and collection of information and data of significant national heritage and cultural aspects from different localities in the country;

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Understanding to be entered into by the City Government of Bacoor and the NCCA to the Sangguniang Panlungsod for its review and consideration.
