A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER INTO AND SIGN THE LICENSING AGREEMENT WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) RELATIVE TO THE CONDUCT OF DREDGING ACTIVITIES AT IMUS RIVER TO RELIEVE THE FLOODING PROBLEM IN THE CITY OF BACOOR.

WHEREAS, constant flooding caused by heavy rains in many areas within the City of Bacoor adversely affect the socio-economic conditions and livelihood of many Bacooreños;

WHEREAS, the City Government is mandated by law to ensure the efficient delivery of public service and to promote the general welfare;

WHEREAS, on 01 August 2022, the Sangguniang Panlungsod received a request from the Office of the City Mayor to pass a resolution authorizing Hon. City Mayor Strike B. Revilla to enter and sign the License Agreement with the Department of Public Works and Highways (DPWH) regarding the conduct of dredging activities at the Imus River to relieve flooding at various areas of the city;

WHEREAS, due to lack of the necessary equipment to pursue the said project, the DPWH extends support to the City of Bacoor by assigning the equipment required to conduct dredging works at the Imus River to remedy flooding which would eventually improve the socio-economic condition of Bacooreños;

NOW THEREFORE, the Sangguniang Panlungsod, after careful review of the matter, through the motion of Hon. Levy M. Tela unanimously seconded by all members





