A RESOLUTION APPROVING CDRRMC RESOLUTION NO. 4-2022 REQUESTING THE SANGGUNIANG PANLUNGSOD TO PASS A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY AT SITIO TRAMO, BARANGAY MALIKSI 2 WHICH SUSTAINED MASSIVE PROPERTY DAMAGES DUE TO A FIRE INCIDENT WHICH BROKE OUT IN THE AFTERNOON OF 12 AUGUST 2022.

WHEREAS, the City Disaster Risk Reduction Management Council (CDRRMC) passed Resolution No. 04 requesting the Sangguniang Panlungsod to declare a state of calamity in Sitio Tramo, Barangay Maliksi 2 which sustained massive property damages when a fire incident broke out in the afternoon of 12 August 2022. A copy of the said CDRRMC Resolution was submitted for the consideration of the Sanggunian.

WHEREAS, around 200 families were affected by the said conflagration and they are now being given temporary shelter at Maliksi Elementary School.

WHEREAS, the Sangguniang Panlungsod deliberated on the said request and was able to confirm the extent of the damage caused by the said fire.


NOW THEREFORE, unanimously approved by all the members present in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to approve City Disaster Risk Reduction Management Council (CDRRMC) Resolution No. 04 and declare a state of calamity in Sitio Tramo, Barangay Maliksi 2 which sustained massive property damages when a fire incident broke out in the afternoon of 12 August 2022.




