**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. STRIKE B. REVILLA, TO SIGN THE OFFER OF FILINVEST LIFEMALLS FOR THE RENT FREE USE BY THE CITY GOVERNMENT OF A COMMERCIAL SPACE WITHIN MAIN SQUARE MALL TO BE USED AS A SATELLITE OFFICE AND DIRECTING THE CITY BUDGET AREAS TO LOOK FOR FUNDS NEEDED TO PAY FOR EXPENSES RELATED TO THE MAINTENANCE OF COMMON AREAS IN THE SAID MALL.**

**WHEREAS**, Filinvest Land, Inc., the registered owner of Filinvest Lifemalls, offered the use of a portion of its property at the Main Square Mall to the City Government of Bacoor to be used as a Satellite Office of the city government located along Bacoor Boulevard, Bayanan, Bacoor City, Cavite.

**WHEREAS**, the City Government intends to establish a Satellite Office for its Business-One-Stop-Shop (BOSS) and other related services for the convenience of taxpayers and of the general public;

**WHEREAS**, Filinvest Lifemalls offers to the City Government of Bacoor the use of a 700-square meter space at the Main Square Mall located at Barangay Bayanan, Bacoor City free of rent;

**WHEREAS**, the term of such use is for five (5) years and thirty (30) days starting on the actual date of operations on November 1, 2022;

**WHEREAS**, a copy of the proposal of Filinvest Lifemalls was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

**WHEREAS**, the City Mayor also requested the Sanggunian to authorize the City Budget Officer to look for funds that might be needed to pay for the expenses related to the maintenance


