






CITY RESOLUTION NO. CR 2022-425  
Series of 2022

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY AT BARANGAY ZAPOTE V, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF ONE MILLION SIX HUNDRED FIFTY THOUSAND PESOS (PHP 1,650,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a residential unit at Sitio Taylan in Barangay Zapote V in the afternoon of 31 December 2021, that rapidly spread to adjacent residential units which were mostly made from light materials thereby affecting around 100 families whose houses were destroyed.

WHEREAS, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 01, Series of 2022 dated January 1, 2022, requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangay Zapote V, City of Bacoor, Cavite and authorizing the release of One Million Six Hundred Fifty Thousand Pesos (Php 1,650,000.00) from the City Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRRMC Resolution No. 01-S-2021 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.
