A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FIRE PROTECTION (BFP) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

WHEREAS, on 11 January 2022, the Office of the City Legal Service requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement (MOA) with the Bureau of Fire Protection (BFP) relative to the online assessment, collection and remittance for fire safety inspection fees for (a) business permit, (b) building permit and (c) occupancy permit.

WHEREAS, Section 12 (h) of Republic Act No. 9485 as amended by Section 11 of Republic Act No. 11032 has vested the BFP the discretion to enter into agreements with municipalities/or cities to allow the latter to assess and to collect fire safety inspection fees provided that the BFP is able to check the accuracy of the computation and to certify the tax order of payment. Provided further, that the remittance of the said fees to the BFP shall be made not later than 2 days after the transaction is made.

WHEREAS, a draft MOA was sent by the Office of the City Legal Service with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration;
