A RESOLUTION AMENDING CITY RESOLUTION NO. CR 2022-452 ENTITLED: "A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTr) REGARDING THE TRANSFER OF FUNDS TO THE CITY OF BACoor FOR THE REMOVAL, RELOCATION AND/OR RESTORATION OF STRUCTURES AND AUXILIARY BUILDINGS THAT MIGHT BE AFFECTED BY THE LRT LINE 1 SOUTH (CAVITE) EXTENSION PROJECT."

WHEREAS, on April 21, 2022, the Sangguniang Panlungsod passed **City Resolution No. CR 2022-452** entitled: **"A RESOLUTION AUTHORIZING THE CITY MAYOR TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRANSPORTATION (DOTr) REGARDING THE TRANSFER OF FUNDS TO THE CITY OF BACoor FOR THE REMOVAL, RELOCATION AND/OR RESTORATION OF STRUCTURES AND AUXILIARY BUILDINGS THAT MIGHT BE AFFECTED BY THE LRT LINE 1 SOUTH (CAVITE) EXTENSION PROJECT."**

WHEREAS, the stated amount in the Memorandum of Agreement to be given by the National Government to the City of Bacoor allotted for the removal, relocation and/or restoration of structures and auxiliary buildings was Fifty Million Two Hundred Thousand Pesos (Php50,200,000.00).

WHEREAS, due to an amendment to the General Appropriations Act done by Congress, the said amount was increased to Sixty Million Pesos (Php60,000,000.00). Thus, an amendment of the previously passed resolution is needed which was requested by the Office of the City Mayor.
