WHEREAS, on 8 April 2022, the Office of the City Legal Service requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign and enter into a Memorandum of Understanding with the National Commission for Culture and the Arts (NCCA) regarding the implementation of the Cultural Mapping Project to be conducted in the City of Bacoor.

WHEREAS, Republic Act No. 10066 otherwise known as the "National Cultural Heritage Act of 2009" provides for the protection and conservation of the national cultural heritage, strengthening the National Commission for Culture and the Arts (NCCA) and its affiliated cultural agencies.

WHEREAS, the NCCA has prioritized the conduct of "Local Cultural Mapping" wherein they can research and collect information and data in significant national heritage and cultural properties in different localities in the country.

WHEREAS, the Office of the City Legal Service with the authority of the City Mayor submitted a draft Memorandum of Understanding to be entered into by the City Government of Bacoor and the NCCA to the Sangguniang Panlungsod for its review and consideration;
