**WHEREAS**, pursuant to Republic Act No. 9470 (RA 9470) also known as the "National Archives of the Philippines Act of 2007" or "AN ACT TO STRENGTHEN THE SYSTEM OF MANAGEMENT AND ADMINISTRATION OF ARCHIVAL RECORDS, ESTABLISHING FOR THE PURPOSE THE NATIONAL ARCHIVES OF THE PHILIPPINES, AND FOR OTHER PURPOSES", the Sangguniang Panlungsod (SP) Secretariat seeks the authority of the Sangguniang Panlungsod to scan and dispose records from 2016 and beyond in the records of the Sangguniang Panlungsod.
