**A RESOLUTION AUTHORIZING THE HON. MAYOR STRIKE B. REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REGION IV-A ON GRASSROOTS PARTICIPATORY BUDGETING PROGRAM FOR AND ON BEHALF OF THE CITY OF BACOR.**

**WHEREAS**, the Human Development and Poverty Reduction Cluster (HDPRC), the Good Governance and Anti-Corruption Cluster (GGAC) and the Economic Development Cluster (EDC) organized under Executive Order No. 43, s. 2011, issued DBM-DILG-DSWD-NAPC Joint Memorandum Circular (JMC) No. 1, Series of 2013 on 03 March 2012 to serve as the basis for the implementation of Grassroots Participatory Budgeting Program (GPBP) for the FY 2013 budget preparation.

**WHEREAS**, the GPBP aims to make the planning and budgeting process of both local and national government more participatory by involving grassroot communities in the delivery of national services to poor communities adopted by different National Agencies and Local Government Agencies as part of their poverty reduction efforts.

**WHEREAS**, pursuant to the DBM, DILG, DSWD, and NAPC issued Joint Memorandum Circular 02 series of 2012 (JMC 03 s. 2012) on 10 December 2012, specifying the guidelines for the implementation and monitoring of GPBP projects for FY 2013, both the DSWD and Local Government Units and or CSOs shall uphold the principle of people empowerment even during the course of and post project implementation.

**WHEREAS**, the DSWD, through the Protective Services Unit (PSU), Kapit-Bisig Laban Sa Kahirapan – Comprehensive and Integrated Delivery of social Services (KALAHI-CIDSS) and sustainable Livelihood Programs (SLP) National and Regional Project Management Offices (NPMO and RPMOs), assisted the HDPRC in the implementation of the pilot phase by facilitating the conduct of GPBP Planning Activities specifically in 223 KC municipalities nationwide.
