**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO NEGOTIATE WITH LANDBANK OF THE PHILIPPINES (LBP) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACORR REGARDING THE OMNIBUS TERM LOAN FACILITY TO BE OBTAINED IN THE AMOUNT OF FIVE HUNDRED THIRTY MILLION PESOS (PHP530,000,000.00) FOR THE PURPOSE OF FINANCING THE CONSTRUCTION OF DISASTER RISK REDUCTION AND MANAGEMENT BUILDING AND VARIOUS PROJECTS WHICH ARE INCLUDED IN THE APPROVED 2021 LOCAL DEVELOPMENT PLAN AND/OR APPROVED ANNUAL INVESTMENT PROGRAM DETERMINED BY THE CITY GOVERNMENT OF BACORR, CAVITE.**

**WHEREAS**, Section 296 of Republic Act No. 7160 (otherwise known as the Local Government Code of 1991) provides that "it shall be the basic policy that any local government unit may create indebtedness, and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the proposed local development plan and public investment programs".

**WHEREAS**, Section 297 paragraph (B) of the same law, further states that "a local government unit may likewise secure from any government bank and lending institution short, term and long term loans and advances against security of real estate or other acceptable assets for the establishments, development or expansion of agricultural, industrial, commercial, house financing and livelihood projects and other economic enterprise".

**WHEREAS**, Section 444 (b) (I) (IV) of the Local Government Code of 1991 also provides that the City Mayor, upon authorization by the Sangguniang Panlungsod, shall represent the city in all business transactions and to negotiate on its behalf of all bonds, contracts and obligations and other documents made pursuant to law or ordinance;
