A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 1 FOR THE CURRENT YEAR 2021 OF THE CITY OF BACOR IN THE AMOUNT OF TWO MILLION TWO HUNDRED SEVENTY TWO THOUSAND TWO HUNDRED EIGHTY FOUR PESOS AND 73/100 (PHP2,272,284.73) BALANCES FROM THE 20% DEVELOPMENT FUND FOR CY 2020 -INFRASTRUCTURE PROJECTS AND ALLOCATE THE SAME TO OTHER PROJECTS OF THE CITY GOVERNMENT OF BACOR.
