**A RESOLUTION EXTENDING THE GRANT OF TWENTY PER CENT (20%) DISCOUNT ON REAL PROPERTY TAX FOR CURRENT YEAR PAYMENTS UNTIL JUNE 30, 2021 IN THE CITY OF BACOR, PROVINCE OF CAVITE.**

**WHEREAS**, Article 7, Section 17 (D) of Bacoor City Revenue Code of 2013 granted a Twenty Per Cent (20%) discount on Real Property Tax up to January 20 of each year for advanced payments only on real properties situated within the City of Bacoor, Cavite.

**WHEREAS**, on 9 November 2020, the Sangguniang Panlungsod passed City Resolution No. CR 2020-269 entitled: "**A RESOLUTION EXTENDING THE GRANT OF TWENTY PER CENT (20%) DISCOUNT ON REAL PROPERTY TAX CURRENT YEAR PAYMENTS UNTIL MARCH 31, 2021 FOR CALENDAR YEAR 2021 ONLY IN THE CITY OF BACOR, PROVINCE OF CAVITE**", in the midst of the COVID-19 pandemic;


**WHEREAS**, the City Mayor requested the Sangguniang Panlungsod to extend the period of avilment of the 20% discount on Real Property Tax for current year payment from March 31, 2021 to June 30, 2021 so as to prevent overcrowding at the Bacoor City Hall of taxpayers and prevent any further increase in the number of COVID-19 cases in the city.
