WHEREAS, the deadline for the issuance and application of business taxes and mayor's permits in the City of Bacoor, Cavite was originally set until 20 January 2021. Upon the request of the City Mayor, the said deadline was extended further until March 31, 2021 through the passage of City Resolution No. CR 2020-268 dated 09 November 2020.

WHEREAS, to prevent overcrowding at the Bacoor City Hall in the midst of the COVID-19 pandemic and in consideration of the implementation of the BOSS Online Billing and Collection System including the application for new and renewal of Mayor's Permits, the City Mayor requested the Sangguniang Panlungsod to further extend the said period from March 31, 2021 to June 30, 2021.
