CITY RESOLUTION NO. CR 2021-337

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN SITIO TIBAG, BARANGAY PANAPAAN III, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF FIVE MILLION SEVEN HUNDRED FIVE THOUSAND PESOS (PHP 5,705,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a house in Sitio Tibag, Barangay Panapaan III which rapidly spread to adjacent houses in the afternoon of 13 April 2021 resulting in massive damage to property and the displacement of around 350 families whose houses were destroyed.

WHEREAS, the City of Bacoor Disaster Risk Reduction and Management Council (CBDRMC) passed Resolution No. 03, Series of 2021 dated 14 April 2021 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Sitio Tibag, Barangay Panapaan III, City of Bacoor, Cavite and authorizing the release of Five Million Seven Hundred Five Thousand Pesos (PhP 5,705,000.00) from the Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRMC Resolution No. 03-S-2021 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.


NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola unanimously seconded by the rest of the council in regular online session duly




