A RESOLUTION EXPRESSING THE CONSENSUS OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOOD, CAVITE NOT TO OBJECT TO THE APPLICATION OF THE UNIVERSITY OF PERPETUAL HELP SYSTEM-DALTA LOCATED AT BARANGAY MOLINO III TO ESTABLISH A SPECIAL ECONOMIC ZONE (KNOWLEDGE, INNOVATION, SCIENCE AND TECHNOLOGY PARK) AT ITS MOLINO CAMPUS ON THE CONDITION THAT THE SAID EDUCATIONAL INSTITUTION WOULD ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CITY GOVERNMENT OF BACOOD IN RELATION TO THE OPERATION OF THE SAID SEZ.

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the rest of the





