A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO NEGOTIATE AND ENTER INTO A MUTUAL CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT WITH GCASH/G-XCHANGE INC. FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR.

**WHEREAS**, GCash is one of the most popular payment and remittance services in the country which is a product of G-Xchange, Inc. (GXI), a subsidiary of GLOBE Telecoms. The GXI is a non-bank Electronic Money Issuer which requires potential clients to initially execute the Mutual Confidentiality and Non-Disclosure Agreement (MCNDA) before entering into any negotiation. Its execution is an important legal framework to protect sensitive and confidential information from both contracting parties.

**WHEREAS**, the City Government of Bacoor intends to use the electronic payment facility as an alternative method for disbursements and collections offered by GCash.

**WHEREAS**, a draft MCNDA was sent by the Office of the City Legal Service to the Sangguniang Panlungsod for review and approval;

**NOW THEREFORE**, upon motion of Hon. Rowena Bautista-Mendiola duly seconded by Hons. Reynaldo D. Palabrica and Alde Joselito F. Pagulayan, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular online session duly assembled to authorize the City Mayor, Hon. Lani Mercado-Revilla, to negotiate and enter into a Mutual Confidentiality and Non-Disclosure Agreement with GCash/G-Xchange, Inc. for and on behalf of the City Government of Bacoor.
