**WHEREAS**, on 22 February 2021, a copy of letter from the City Vice Mayor Ernesto T. Matugas on behalf of City Mayor Ernesto U. Matugas, Jr. and the people of Surigao City was sent to the Office of the City Mayor Lani Mercado Revilla to inform formally its keen desires to enter into a Town Affiliation Program with the City of Bacoor for it to become its city's Sister City.
